1. Information We Collect and Why

Account and identity (name, email) for account creation, authentication, and support.

Subscription and billing (purchase history, tier, renewal status) to process payments, manage entitlements, and prevent fraud.

Device and app data (device model, OS/app version, language, crash diagnostics) to keep the Service secure and reliable.

Usage data (e.g., habit completions) and general analytics to improve features and product experience.

Communications (messages you send to us) to respond and resolve issues.

We do not sell your personal information.

2. Log Data

We may collect technical data such as IP address, device identifiers, app or browser version, pages or screens viewed, timestamps, and diagnostics to maintain security, analyze usage, and improve performance.

3. Cookies and Tracking

We use cookies and similar technologies on the website to keep you signed in, remember preferences, and analyze traffic. You can disable cookies in your browser settings, but some features may not work properly.

4. Emails and Communications

We may send transactional emails such as receipts and critical notices. With your consent or where permitted by law, we may send product tips, updates, or newsletters. You can unsubscribe at any time using the link in those emails.

5. Data Storage and Security

Your data is stored on secure servers. We use encryption (including HTTPS/SSL in transit) and industry-standard safeguards to protect your information. However, no method of transmission or storage is 100% secure.

6. Third-Party Services (Processors)

We may use trusted providers to operate parts of the Service. These providers act as processors, may process personal data only to perform services on our behalf, and must not use it for other purposes.

Examples: Apple (In-App Purchases), Stripe or PayPal for billing; Google Analytics and Firebase for analytics and diagnostics; email delivery providers for receipts and notifications.

7. Children's Privacy

Qube Goals is not directed to children under 13. We do not knowingly collect personal data from children under 13. If you believe a child provided personal data to us, please contact us and we will promptly delete it.

8. Data Retention and Deletion

We retain personal data only as long as necessary to provide the Service or comply with legal obligations. You may request deletion of your account and associated personal data by contacting us. We may keep limited records as required by law (for example, tax or audit).

9. Your Privacy Rights (GDPR/CPRA)

Depending on your location, you may have rights to access, correct, delete, or port your data; object to or restrict certain processing; and opt out of targeted advertising or the sale or sharing of personal information under CPRA.

For EEA/UK users, our lawful bases may include performance of a contract, legitimate interests, legal obligation, and consent where required.

10. International Transfers

We are based in the United States and may process information in the U.S. and other countries. Where required, we rely on appropriate safeguards for cross-border transfers (such as Standard Contractual Clauses).

11. Do Not Track

Some browsers offer a Do Not Track (DNT) signal. Because there is no common industry standard for DNT, our websites may not respond to these signals.

12. Changes to this Policy

We may update this Privacy Policy from time to time. If significant changes occur, we will notify you (for example, via email or in-app notice) before they take effect. Continued use after updates become effective constitutes acceptance of the revised policy.
